THE FACULTY OF LAW

II

THE PROGRAMME

The programme provides an in-depth investigation of both the practical and the theoretical aspects of business law within the European Union and of how the Internal Market operates in a global context. EU law is addressed from the founding principles that form the basis for the in-depth discussions of business law within the European context.

The programme ranges from an exploration of the European Union's constitutional foundations to extensive study of topics central to the business environment or to economic analysis. The Master in European Business Law provides training in technically specialized areas within European law, such as free movement law, competition law, contract law, intellectual property law and tax law.

To provide a truly European flavour to the programme and to ensure a good balance between academic study and practice, the programme uses a blended teaching approach. This approach builds on foundational knowledge by showing the practical application of the law in an everyday commercial context. To support this approach, we have strong external partners from private practice, commercial corporations, institutions of the European Union, governmental institutions, and the judiciary at both the Swedish and the European level.

Using our blended learning system, we ensure that the programme provides an in-depth understanding of both the practical and the theoretical aspects of business law in the European Union and of how the internal market operates in a global context. With an increase in legislation, influence, and commercial policy at the European level there is a growing importance for the commercial lawyer to have awareness of the European legal framework. Given this growing importance and the ever-expanding commercial activity across borders the European Union is a natural platform for students dedicated to cross-border and global business issues.

The programme structure allows students to specialize in fields of their interest which enables them to create a unique competitive edge for any future position or assignment on the labour market.

The teaching staff is experienced within the academic field as well as within the private sector which contributes to the diversity of the programme.

Programme Duration

The Master (Two Years) of Laws in European Business Law is an academic programme at the second level, offered in English and open to Swedish and foreign students with at least a three-year degree in Law (Bachelor, LL.B., or equivalent). Students have the possibility to conclude the studies after one year and obtain a degree of Master (One Year) of Laws in European Business Law – *Magisterexamen i europeisk handelsrätt*.

Programme Structure

The two-year programme is broken down into four terms. Each term is broken down into two periods and is comprised of a mixture of compulsory and elective courses. Each period is comprised of 15 credits and each term is made up of 30 credits.

** Electives are only available to those students who are taking the two-year programme. Students taking the one-year programme are required to undertake the master thesis.*

Elective Courses

Elective courses vary from year to year and offer in depth, up to date and specialist areas that students can choose to specialize in. Courses are generally 15 credits although there may be some courses of only 7.5 credits, and students will be required to study at least two such courses in any given period to complete the necessary 15 credit requirement per period.

INDUCTION WEEK

The first week of the programme is Induction Week. For the 2024 academic year, induction week will take place from the 2nd of September to the 6th of September. The purpose of Induction Week is to provide students with a refresher on the basic aspects of the EU, its history, its institutions, and its law, and to provide necessary information about the rules and expectations at Juridicum.

The Induction Week

During Induction Week a series of classes are arranged designed to help you settle in and get to know your way around campus as well as providing you with key course induction sessions. Induction Week also gives all new students an introduction to life at Juridicum. During the induction sessions we aim at covering the framework of the European Union and refreshing the main cornerstones of the Union law that influence the programme. During the week, students are given the opportunity to meet the teaching team and other new students on their course and take part in induction activities to prepare them for the start of their programme, whilst the course directors and administration will be available to answer any questions you may have.

The induction sessions offer a broad range of lecturer on different areas of European law, such as the making of EU law, internal market law, competition law and commercial aspects of contract and sales law in the EU. You will also be familiarized with the methods and content of legal argumentation. The induction sessions provide the basis for your future in-depth exploration of EU law. Within the induction sessions you will also be introduced to the formal requirements of Juridicum, exam techniques and thesis writing. We have also included a library induction session to get you started and familiar with the library system and access to the electronic resources available to you.

The Format of Induction Week

Induction Week typically runs from Monday to Friday. Each session is typically designed to run for 2 hours and will cover a specific topic on the Induction Week objectives.

Preparation

The induction sessions are structured as interactive lectures, requiring you to contribute and participate with commentary, opinion, and questions. The schedule is set out below.

If you are unfamiliar with any of the substantive EU sessions it is recommended that you undertake self-study to bring your knowledge to a standard that you are comfortable with in order to effectively participate in the class discussion.

In particular, you should watch the relevant videos on the BLACKBOARD platform or read the relevant reading material as provided the next section RECOMMENDED MATERIALS.

The BLACKBOARD platform will be available to you once you are registered.

Attendance

While Induction Week is not compulsory it is expected that students registered on the programme will attend the classes.

If you are unable to attend for any reason, as a result of a travel delay for example, we expect you to inform us of this. Induction Week, not only, provides an EU refresher and necessary information about the rules and expectations at Juridicum, but it also introduces and delivers the core knowledge that the early courses build on.

Mandatory Participation

Formative Assessment

The expectation on what makes a good essay at Juridicum might differ from expectations at other universities. We therefore cover this area as part of the induction week. To ensure proper preparation for the programme, you have the possibility to write a 500-2000 words formative assignment which will be peer-assessed and discussed on the last day of the induction week.

We have set essay questions for every topic covered during the week. There is also a writing day planned for the week so that you have enough time to write the assignment.

Please pick one topic and write a 500-2000 words essay. On the first day you will be allocated a peer to review your paper who will then be asked to send the paper with her/his comments to eduardo.gill-pedro@jur.lu.se who will discuss the papers with you on the last day of the induction week.

All papers must arrive to Eduardo with their comments by Thursday 12.00 noon.

The questions are the following:

- The current crisis in the EU with Brexit and the refugee crisis shows that EU has failed and that it is obsolete today. Discuss

- The EU institutions show that the EU is State-like and not an international organisation. Discuss
- The law of the European Union can be characterised as something between national and international law. Discuss
- The internal market is an unnecessary element of the EU that does only create problems. Discuss
- Competition law is an essential element of any modern legal system covering business relationships. Discuss
- There is a body of law that can legitimately be called European Contract Law. Discuss

VI

EU CONSTITUTIONAL LAW

EU Constitutional Law commences following the end of Induction Week. The purpose of the course is to provide in-depth knowledge of the constitutional aspects of the European Union which forms the foundation of all further understanding and discussion of commercial aspects of EU law. The course focuses on and explains the balance of power between the Union and member states; constitutional principles such as the principle of subsidiarity; comitology; implementation of Community law in the member states; fundamental rights which have growing significance in commercial litigations and company defences and finally the enforcement and the role of the courts of the European Union.

Structure of the Course

The course is delivered through a combination of lectures and seminars. Given the fluidity and dynamism of constitutional law in the Union the seminars are designed to be discursive, requiring that students be prepared and opinioned to be able to jointly explore the challenging area of European constitutional law. The course requires substantive amounts of reading and engagement of the highest degree and will cover important topics such as supremacy, competence, pre-emption, direct, indirect, and other types of "effects", fundamental rights, and the role of the European courts and the relationship to national courts and member states constitutional orders.

VII

BUSINESS NEGOTIATIONS

This course combines the study of commercial negotiation and contract drafting from a theoretical and practical perspective. The theoretical part is based on studying certain aspects of negotiation and drafting practices. At an academic level, the focus lies on studying the main principles underpinning the role of lawyers as negotiators and drafters. Students will engage and develop an understanding of common values underlying contract law, understanding these values can help a practitioner appreciate the goals and assumptions underlying the legal rules involved in drafting contracts.

The practical element focuses on negotiation in a transactional setting, allowing students to develop negotiation skills and understand the dynamics of negotiation and how this interlinks with the conclusion of a balanced contract, and the effect this has for founding an enduring business relation. In parallel, students will be required to draft an agreement which results from a negotiated deal. This focuses on the skill and ability to effectively reduce the terms of a negotiation into a clear, functional, and enforceable legal instrument. Accordingly, this course will offer an integrated consideration of these two core skills, exploring them in tandem and aiming to develop an appreciation for their practical and conceptual relation.

Structure of the Course

The course is delivered through a combination of lectures, seminars, and group work. Students will be required to negotiate out a scenario and deliver a fully drafted and completed agreement.
